Agenda Topics

• RIC:

- o Kim Fry presented a history of the RIC (see recap document previously sent.)
- o RIC team wants to seek Congregation approval of Shepherd of the Mountains commitment to be an RIC partner, and is asking Council to include this on the agenda at the May meeting.
- o Discussion of the proposed Welcome Statement included the following:
 - Why does RIC believe it's necessary to identify specific groups?
 - Are we focusing the Welcome Statement on a small percentage of the population?
 - How effective has our current Welcome Statement been?
 - Can we massage the Welcome Statement so it's less specific?
 - Welcome Statement is not an Evangelism tool.
 - Without a deliberate Welcome Statement people won't come to church.
 - The Welcome Statement is a disciple issue we are following Christ.
- We need to be more deliberate in welcoming all new attendees to church.
- o RIC team needs to generate discussions around the proposed Welcome Statement, much like has happened with the recent Adult Ed discussions.
- o Jennifer to talk to the RIC team about promoting these discussions.

• Transition Update:

- o Have received 4 nominations for Transition Team. All are great candidates.
- o Request that every Council member submits a nomination.
- o Candidates should not have an agenda.
- o Diversity of candidates is important.
- No self-nominations.
- o Alison to provide update regarding nominations at services on March 19th.

 Need to figure out Fellowship and Social Ministry committees. Desire to have two Chairs but committees can meet at the same time if necessary.
