

d. Energy produced via solar panels:



- \$6500 spent on remediation for flood in the basement.
- Expect insurance will cover some portion of the remediation.
- Overages in electricity, snow removal, plumbing and electricity due to the above average snowfall this year.
- Leaks in Sanctuary, Pastor office, and church office will need repair this summer at an estimated cost of \$73K.
- Withdraw from Operating Checking Account to cover cost of roof repair.

A motion was made and seconded to authorize spending up to \$73K for roof repairs. The motion passed by majority vote.

A motion was made and seconded to approve the slate of officers for 2023/2024. The motion passed by majority vote.

6. Reconciling in Christ Update: The Congregation voted on the following initiative.

Under the guidance of leadership from the Reconciling in Christ Core Team, with support from the Shepherd of the Mountains Church Council and Interim Pastor, Shepherd of the Mountains Lutheran Church is voting to become Reconciling in Christ (RIC).

The purpose of the Reconciling in Christ (RIC) Program is to ensure the welcome, inclusion, celebration, and advocacy for people of all sexual orientations, gender identities, and gender expressions; work for racial equity and commit to anti-racist work, and support the national program.

To be recognized as a Reconciling in Christ (RIC) Partner, we will

- 1) Clearly state a welcome to people of "all sexual orientations, gender identities, and gender expressions" or "LGBTQIA+" people and name our commitment to "racial equity" or "antiracism":
- 2) Be open to calling LGBTQIA+ and Black, Brown, Indigenous, People of Color (BIPOC) Rostered Leaders;
- 3) Allow for our sanctuary/community space to be used for LGBTQIA+ weddings and blessings; and
- 4) Make a meaningful contribution annually to support the national RIC program.

In voting yes today, you are voting to affirm the commitments to become RIC, and adopting the following welcome statement:

As all people are created in the image of God, we embrace diversity in our congregation and community, and we affirm the dignity and worth of every person. We honor the guiding principle that discrimination is incompatible with Christ's unconditional love and we are committed to racial equity. We boldly embrace, love, celebrate and welcome persons of all faith backgrounds, races, ethnicities, cultures, ages, abilities, sexual orientations, gender identities and gender expressions. Everyone has a place here. All are welcome!

A motion was made and seconded to approve the resolution. The resolution passed by majority vote.
